ELECTRONIC BID SUBMISSIONS ONLY, shall be received by the Tendering System. Hardcopy submissions not permitted.

This Contract is for the reconstruction of First Street East between Central Avenue and Mowat Avenue, works also include miscellaneous hydrant and valve replacements, and provisional storm sewer repairs. The works on First Street East include but are not limited to sanitary sewer, watermain, storm sewer, water services, earth excavation, granular 'A' & 'B', concrete sidewalks, curb and gutter, line painting and hot mix paving.
