Reminder of By-Law 16-06

Non-essential use of Water By-Law takes effect May 15th to September 15th

Those at ODD NUMBERED addresses may use non-essential use of water on odd numbered calendar days, and those at EVEN NUMBERED addresses may use non-essential use of water on even numbered calendar days.

The restrictions imposed above are not in **effect on the 31st day of any month.**

DEFINITIONS

Non-essential use of water shall include watering of lawns and gardens, filling of swimming pools, washing of vehicles (other than commercially-operated car washes) and any other use of water which is not essential to public health and safety, personal hygiene, or to sustain a commercial activity at the municipal address where water is used.

Where a person has made application in writing to the By-Law Enforcement Department of the Corporation for exemption from the provisions the By-Law Enforcement Department may at its discretion, and having considered the merits of the circumstances surrounding the request, give in writing an exemption from the provisions.

Any person who fails to comply with the restrictions of this by-law or fails to comply with a directive given under Section 9 is guilty of an offence, and upon the conviction thereof, is liable to a maximum fine of \$300.00 (three hundred dollars).

In addition to the above penalty upon the violation of any terms of this by-law, the Corporation may discontinue water service to the property of the person in this contravention. There is a fee for having water turned off/on.

GRANTS & ROADS

ANSWERING YOUR QUESTIONS

This section will be dedicated to addressing some of those concerns expressed surrounding grants and funding department projects.

THE TOWN RECEIVED A GRANT - WHY CAN'T IT BE USED ON ROADS?

Grants like the Northern Ontario Heritage Fund Corporation, FedNor, and the Ontario Trillium Foundation Resilient Communities Fund have prescribed usage, such as promoting economic development or supporting community initiatives. The recent grants to Sunny Cove, Hallett and Owandem, and the Museum align with these purposes making them eligible, while road projects are not. To ensure future eligibility, we need clear reporting demonstrating that the money was used for its intended purposes and not diverted to other areas.

WHY DOES THE TOWN NOT APPLY FOR GRANTS FOR ROADS?

We do! Our Operations & Facilities team works hard in applying for these grants so these projects are not entirely paid for by taxpayers. We shared this information quite recently on our March 15th newsletter, but are happy to highlight it again in case you missed it:

COMPLETED WORK

- **2022 King's Highway** reconstruction, grants covered **90%** of the project
- **2022/23 Mowat Avenue** reconstruction, grants covered **98%** of the project
- **2023 Sinclair Avenue** reconstruction, grants covered **59%** of the project

UPCOMING/PLANNED WORK

- **2024 First Street East** reconstruction, grants set to cover approximately **96.4%** of the project
- **2024 Third Street West** reconstruction, grants set to cover approximately **66%** of the project
- **2024 parts of 5th Street West and 6th Street** resurfacing, the Town is **applying for grants** to help fund this project

WHY DOES THE TOWN PRIORITIZE FUNDING FOR OTHER DEPARTMENTS OVER ROADS?

Efforts to maintain roads and infrastructure are ongoing, and these projects require careful planning to manage resources effectively. Rapid solutions would impose hefty financial burdens, not in line with residents' preferences.

The Town's budget allocations aims to address diverse needs beyond only roads. While roads and infrastructure are crucial for safety, longevity, and connectivity, it's essential to recognize that a vibrant town encompasses more than just its thoroughfares.

From recreational facilities to cultural landmarks to municipal staples such as libraries, museums, parks, each plays a vital role in community well-being and in attracting residents, businesses, and tourists. This is exemplified in our strategic plan, which gathered resident input through multiple available opportunities to do so in 2023 (such as public sessions, surveys). We must consider the entire community's needs holistically and do our best to utilize available funds from taxes, revenue, funding, and grants efficiently.

We work hard to apply for all funding opportunities available to us to assist in operational expenditures as well as capital and asset management planning. The Town has been very successful in receiving grants in the recent past, but is not successful in every application.

WHY IS THE PUBLIC NOT PART OF THE BUDGET PROCESS IN SETTING PRIORITIES?

You're welcome to attend every budget meeting to voice your comments, ideas, questions, or concerns, or submit correspondence for Council consideration. This is your opportunity to directly influence how we prioritize departments and projects, including roads. Unfortunately we often receive public input and ideas too late or through non-Town channels. Watch our website and socials this fall for public 2025 Budget Deliberations.

REMINDERS OF SUMP PUMPS

Per By-Law 06-16 - **Regulation of the Sewer System in the Town of Fort Frances** - Section 8.2 (b) **"Weeping Tile Sump Pumps may only be discharged to the sanitary sewer between October 15th and March 31st.** As of April 1st, no weeping tile sump pump is permitted to be discharged to the sanitary sewer system."

Please ensure that your sump pumps are pumping outside to the surface, ditch, or storm sewer system, and not to the sewer system.
